General Graduation Guidelines:

- Total of 120 semester hours, 33 of which must be numbered 300 or 400 (Other programs may require coursework beyond 120 semester hours)
- At least 9 semester hours of courses designated as writing intensive
- A declared major
- A cumulative GPA average of C (2.00) and at least a C average in the graduation major

WHAT YOU WILL LEARN:

- Knowledge of generally accepted accounting principles, accounting theory and business practices
- Basic structure of accounting, accounting systems, balance sheet accounts, the income statement and the statement of cash flows
- A survey of the primary functions of management including planning organizing, leading and controlling
- Basic knowledge of deductions, depreciation, capital gain and losses and deferred compensation of individuals
- Principles of corporate finance including analysis of financial statements, ratio analysis and the statement of cash flows; capital budgeting; risk and return; stocks and bonds; cost of capital; financial institutions; securities markets; international finance
- The use of cost data in decision making
- Taxation for partnerships and corporations
- Preparation for CPA license, for advanced graduate studies as well as careers in business and accounting
