## General Graduation Guidelines:

- Total of 33 semester hours of MSBA coursework
- Completion of all MSBA coursework within five years of enrolling
- A cumulative GPA average of B (3.00)
- Minimum final grade of C in any course, no more than two grades of a C

## LEARNING OUTCOMES:

- An understanding of behavioral characteristics and reasons for organizational change, as well as which leadership styles are best suited for different environments and situations
- Demonstrate knowledge of ethical problems in business and foundations for decisions involving ethical issues
- Analyze accounting information for decision making and performance evaluation
- A general overview of the legal system and process in the United States
- Apply economic theory and methodology to managerial decision making problems within various organizational settings, such as a firm or a government agency
- A broad understanding of the breadth, depth and application of concepts involving corporate governance, capital budgeting, the cost of capital, leverage, optimal capital structures, Modigliani-Miller (MM) Propositions, dividends, financial statement analysis and mergers and acquisitions

## ADMISSIONS CRITERIA:

- An undergraduate degree in BUS or related field
- Resume with two references (must be able to provide reference letters upon request)
- Complete a statement of purpose
- No GRE or GMAT required
- Minimum undergraduate GPA of 2.5

*Note: Graduate school applicants with a cumulative GPA below 2.5 may still be considered based upon other factors submitted in the application.*
