#### **VA Benefits Overview**

#### Post-911 GI BILL® (Ch 33)

The Post-911 education benefit provides up to 36 months of education benefits for service members who have served on active duty for 90 or more days since 10 Sep 01. Service members should provide a DD214 or Certificate of Eligibility to their School Certifying Official (SCO) (see Contacts page 24).

#### **Tuition and fees**

VA pays up to \$27,120.05 (eff. 8/1/23 – 7/31/24) directly to the college per school year based on the enrollment rate of pursuit. Students using VA and tuition assistance (TA) together must use TA funds first, VA Benefits will then cover tuition remaining up to the yearly cap.

#### **Monthly Housing Allowance (BAH)**

- BAH (based on the rate of E-5 with dependents for the ZIP code of your designated facility) and book stipend are sent directly to the student.
- Based on training time. In a traditional semester, you
  must be enrolled in 12 SH to be considered full-time
  training. For non-traditional, you must be enrolled
  in at least 6 SH per term.
- For full monthly housing allowance, the student must be enrolled in at least one seated or hybrid course. If you are taking online (distant) classes only, BAH will be paid at the rate of 50% of the national average.

#### **Textbook Stipend**

- The annual textbook stipend is \$1,000 and is paid (based on the number of credit hours enrolled) along with the first BAH housing payment, after certification is complete.
- The VA pays the textbook stipend directly to the student.
- Traditional Student textbooks are included in the cost of tuition. This in no way affects the CH 33 VA textbook benefit.

#### **Transferring Benefits**

The VA allows active-duty service members, on or after 1 Aug 09, to transfer some/all benefits to their spouse and/or dependent children.

- Transfer requests must be approved while the member is on active duty.
- Must have at least 10 years of service in the Armed Forces.

- Once the transfer is approved by the Department of Defense (DOD), the new beneficiaries must apply for them at VA. (See the Getting Started Checklist on Page 4).
- Family members should provide the Certificate of Eligibility to the school's VA Coordinator, although it is not required.

#### **Spouses**

- May start to use the benefit immediately.
- May use the benefit while the service member remains in the Armed Forces or after separation from active duty.
- Are not eligible for BAH while the service member is serving on active duty.

#### Children

- May start to use the benefit only after the individual making the transfer has completed at least 10 years of service in the Armed Forces.
- May use the benefit while the eligible individual remains in the Armed Forces or after separation from active duty.
- May not use the benefit until he/she has attained a secondary school diploma (or equivalency) or has reached age 18.
- Entitled to the monthly housing allowance stipend even though the eligible individual is active duty.
- May not use the benefit after reaching 26 years of age.

#### **Montgomery Select Reserve (CH 1606)**

The Montgomery Select Reserve program provides education and training benefits to eligible members of the Select Reserve, including the Army Reserve, Navy Reserve, Air Force Reserve, Marine Corps Reserve and Coast Guard Reserve, and the Army National Guard and the Air National Guard

- Eligibility is determined by the Select Reserve components and VA makes the payments.
- Pays monthly stipend directly to the service member based on rate of pursuit.
- Veteran is entitled to receive up to 36 months of education benefits.

Remedial classes must be taken as Resident classes.
 VA will not pay for remedial online classes.

#### To qualify:

- Have a six-year obligation to serve in the Selected Reserve.
- Complete the initial active-duty training.
- Must have received a high school diploma or equivalency before completing initial active-duty training (IADT).
- Remain in good standing while serving in an active selected reserve unit.
- Eligibility ends the day the student leaves the Selected Reserve.

#### **Veteran Readiness & Employment (CH 31)**

VA VRE is not considered a VA education benefit. The purpose of VRE is to help veterans with service-connected disabilities and barriers to employment to become suitably employed.

- To qualify for this benefit, the veteran must have an honorable or other than dishonorable discharge and have a VA service-connected disability rating of 10% or more, or memorandum rating of 20%.
- A maximum of 48 months of entitlement.
- May be used within 12 years from the date of initial VA disability rating notification.
- Works with a VA VRE Counselor to determine a program of study suitable with disability.
- VA pays full tuition, allowance for books and supplies, a monthly stipend based on credit

- hours taken, and some additional school-required expenses (laptop, software, etc).
- Once approved, the VA VRE will send the VA Coordinator a purchase order authorizing the veteran to take classes in the approved program.
- Veteran follows all academic policies of the school and meets with VRE Counselor each semester for review of grades and approval for enrolling the next semester.

#### **Dependents Education Assistance (CH 35)**

The Dependents Education Assistance program offers education and training opportunities to eligible dependents of veterans who are 100% permanently and totally disabled due to a service-related condition or who died while on active duty or as a result of a service-related condition.

- Spouse may receive 45 or 36 months depending on the date they first began using their benefits.
- For surviving spouses of service members who died on active duty, benefits end 20 years from date of death.
- Children may receive 45 or 36 months depending on the date they first began using the benefits and must be ages 18-26.
- Pays monthly stipend directly to the dependent based on the credit hours enrolled.
- Remedial classes must be taken as Resident classes. VA will not pay for remedial online classes.

## **VA Benefits Frequently Asked Questions**

How do I receive my benefits at North Carolina Wesleyan University? Complete a VA Student In-Processing Form –and submit it to your designated School Certifying Official at VAQuestions@ncwc.edu. https://ncwc.edu/admissions/applyfor-admission/financial-assistance/veteran-benefits/vastudent-form/ (See page 4)

When do I submit the Enrollment Certification Form? You must be officially accepted, and your transfer credits must be officially evaluated. Then, you will submit the VA Certification Request Form along with your registration each time you register. (See page 4)

How do I get a Certificate of Eligibility (COE)? Go to the official web site of the Department of Veteran Affairs at <a href="https://www.va.gov/education/how-to-apply/">https://www.va.gov/education/how-to-apply/</a> and complete an electronic application by clicking on the Green button "Find Your Education Benefit Form." Select "Apply for a new Benefit." Follow the prompts. (See page 4)

Can I be certified without a COE? Yes, however, only the Department of Veteran Affairs can determine eligibility for VA benefits. We are only estimating what they will pay. You will be responsible for any amount of your debt in which the VA has determined they will not pay. If you are unsure, wait until you receive your COE.

I am using my parent or spouse's benefits, can I give you their COE? No, those documents state that *they* are eligible, not *you*. You must have a COE with your name on it **or** the approved Transferability Authorization and *submitted* VA Form 22-1990E (refer to "How do I get a Certificate of Eligibility" above)

#### How do I apply for the Yellow Ribbon (YR) Scholarship?

You must complete the Yellow Ribbon Application and submit it to your SCO <a href="https://ncwc.edu/admissions/apply-for-admission/financial-assistance/veteran-benefits/yellow-ribbon-application/">https://ncwc.edu/admissions/apply-for-admission/financial-assistance/veteran-benefits/yellow-ribbon-application/</a>. NCWU currently selects five (5) Yellow Ribbon students per year (Must be CH 33 at the rate of 100% and must exhaust all benefits before eligible) on a first come, first served basis. Each YR student receives an additional \$1000 grant from NCWU, which is matched by the VA for a total scholarship of \$2000. (See page 16)

Can I get other financial aid? You may possibly qualify for PELL grants, outside scholarships or grants and student loans. The first step would be to complete a Free Application for Federal Student Aid (FAFSA). Go to <a href="https://studentaid.gov/h/apply-for-aid/fafsa">https://studentaid.gov/h/apply-for-aid/fafsa</a> to complete the form then talk to our financial aid counselors in the Office of Financial Aid. NCWU School Code is 002951.

#### How will other financial aid affect my benefits?

We are required to report to VA the net tuition cost <u>after</u> applying tuition-specific grants, scholarships, discounts, etc. VA pays the balance under Ch 33 Post 9/11 Bill.

How do I get transfer credit for my military training? You must provide an official copy of your military record during the admissions process along with your prior college transcripts so it can be evaluated. Each service has a website to request official transcripts. (See page 9)

What are approved courses? All of the academic programs at NCWU have been approved for Veterans Education Benefit; however, only those courses required for your declared major may be approved for your benefit (and electives, if needed).

Why can't I sign up for elective classes if I cannot get a fulltime schedule? VA will pay only for those courses required for your program. If electives are needed, you can. Meet with your academic advisor to determine if you need electives for your degree.

Can I change my major? Yes. We recommend you first consult with your Academic Advisor. You can submit your major change by clicking on the Student Tab, then Registration Video/Forms, Major/Minor Declaration Form in My.NCWC. Be sure to mark that you are using Veteran Benefits on the form.

What if I want to double major? You may be approved for a minor or dual major but you must have at least 50% of your major requirements completed before you can be certified outside your declared major. You should also confer with your Academic Advisor and VA Certifying Official before adding a minor or additional major.

Will VA pay the additional fees if I take a directed study or independent study class? No. VA will not pay for the additional fee, they will pay for the tuition cost. Additional fees would be your responsibility. Courses taken on a pass-fail basis or for audit are also not covered by VA Education Benefits.

# My instructor says I need a specific type of (calculator, instrument, etc.), will VA pay for it?

The CH 33 Benefits <u>will only pay the fees that are required</u> <u>for all students</u>. Fees for applied music lessons, PGM fees, tennis fees, parking fees, etc. are not covered. If you are using CH 31 VRE, your VA career counselor may approve additional required expenses.

How can I get my books now? Your VA book allowance is sent to you on the first day of the month for the previous month. If you have financial aid, you can ask the bookstore to charge your student account. Traditional students' tuition includes the cost of book rental.

#### I am not doing very well in my class, should I withdraw?

That would be your decision, however, if you drop a course after the add-drop period you will have to reimburse VA for the charges they paid in advance. VA pays for each day you attend class. **The VA does not pay for non-attendance.** 

If I stay in the class, I might fail and then I'd have to pay VA back too, right? No, an F means you attended class but did not score high enough to pass; VA will pay for the course and pay for you to re-take it and replace the failing grade; however, you must maintain Satisfactory Academic Progress (SAP) as described in the NCWU catalog. Failure to maintain SAP will result in termination of VA benefits. Repeating classes will adversely affect your SAP but will positively affect your GPA.

What if I just stop going to the class? In that case you will receive a grade of "XF," which is a punitive grade. It would affect your GPA the same as an F, and you would have to repay the VA for that course. If you receive a monthly stipend, (BAH), you will only receive payment through the last day you attended. The VA does not pay for non-attendance.

I want to stay on campus, does the VA housing stipend pay for that? Yes and no; the housing stipend for the CH 33 benefit is a flat rate payment based on the ZIP code of the facility in which you attend and is paid directly to the student at the end of each month. This amount may or may not cover the cost of room and board at the school. The charges are payable at the time of registration. It's your responsibility to sign up for a payment plan (Business Office -BusinessOffice@ncwc.edu). Online courses will be determined by the ZIP code of the course location or home campus or 50% of the national average if classes are all distance/online.

Will I get paid during the break between semesters? Benefit payments for all chapters will only be paid during the term dates. President Obama issued an Executive Order on January 5, 2011, revoking authority from VA to pay the break pay after August 1, 2011.

I called the VA and they said my payment was sent to the school but the Business Office says it has not been credited to my account. Why are you holding it? We ask that you allow 14 days for the payment to be processed by the various departments (Veteran Services Office, Financial Aid, Institutional Computing, Business Office) for checks and balances, to ensure accuracy and to make any changes that may be necessary (For instance, if you have any course changes since your initial registration and issuance of financial aid award letter). I have made no changes why does it take so long to process mine? While your particular case may be a simple one the person whose payment we received before you may need a lot of attention. We ask that you be patient and allow us to take the time and care necessary to be accurate.

I did not receive a W-2 from VA. Do I need to pay taxes on my VA education benefits? No. Any veterans' benefits paid under any law administered by the Department of Veterans Affairs (VA) should not be reported as income to the Internal Revenue Service (IRS). You will not receive a W-2 from the VA.

## **Ordering Military Transcripts**

Students who have satisfactorily completed basic military training will receive four semester hours of transfer credit. Other military training may also be transferred depending on the Registrar's evaluation.

## **Military Deployment Policy**

**Statement:** North Carolina Wesleyan University appreciates the dedication of our students who continue to serve on active duty, guard, or reserves while pursuing their education.

**Purpose:** This policy provides equitable consistent treatment to its military students who are deployed or placed on active-duty status so that they may continue their education once their deployment or military service is complete.

**Policy:** Students who are deployed/placed on active duty (defined as anyone with official active-duty orders including reservists and guard members serving on regularly scheduled Unit Training Assembly (UTA) weekends) status during the term they are enrolled may choose one of the following options:

- A. Continue the coursework through online participation or correspondence. When deemed feasible by the instructor, the college will allow the student to continue the course by making arrangements with the instructor using either online resources or email correspondence during the time of deployment/active-duty status.
- B. Receive a grade of "incomplete." The instructor would allow the student to continue working on the coursework for a time to be determined but no longer than 8 weeks past the term end date. Student must complete the course requirements within the period of time specified by the college to avoid receiving a failing grade for the

- course. Instructors will provide the student in writing the assignments due and due date(s).
- C. Drop without penalty. Student will complete the drop form and submit it to the registrar's office or campus director (adult degree). Student is required to complete the Add/Drop form and submit to their academic advisor.
- D. In the event that a student is required to participate in a field trip or other activity outside the normal class meeting which conflicts with a scheduled drill weekend (UTA), the student will be excused from the activity and given the opportunity to make up work at a later time within the course when feasible.

Student's Responsibilities and Procedures: Student must alert their instructors as soon as they have a conflict or prior to the start of class, whichever occurs earlier by completing the Military Leave Request. Copy of form along with official paperwork should also be submitted to their instructor for signature, and forward to either the Registrar (traditional/or their academic advisor (Adult Studies) with a copy to the School Certifying Official. **Readmission:** Students returning from deployment will be readmitted at the same academic status as they had when previously attended.

## **NC National Guard Tuition Assistance Program**

<u>Apply through the College Foundation of North Carolina (CFNC)</u> - Must be an active member of the NC Army or Air National Guard, remain a member of the National Guard for two years following the end of the academic period for which tuition assistance is provided, must enroll in an eligible business or trade school, private or state educational institution in North Carolina and must satisfactorily complete courses in which tuition assistance is provided. <a href="https://www.cfnc.org/pay-for-college/scholarship-search/north-carolina-national-guard-tuition-assistance-program-nctap/">https://www.cfnc.org/pay-for-college/scholarship-search/north-carolina-national-guard-tuition-assistance-program-nctap/</a>

## **Military Tuition Assistance**

<u>Coast Guard, Marines and Navy</u> – Meet with your military education service officer first, then submit a copy of your Tuition Assistance Authorization Voucher to the NC Wesleyan Tuition Assistance Coordinator, Laura Brown (LEstes@ncwc.edu).

**Army and Air Force** Meet with your military education service officer first, then complete all required forms as advised through the Base/Post Education Center where you are stationed.

- Once you have completed the required steps with your Education Services Officer, the University Tuition Assistance Coordinator must submit an invoice for the courses through the AI Portal (https://aiportal.us.af.mil/aiportal/Account/Login)
- Payment is made to the schools after the course is 50% complete.

#### **Important Tuition Assistant Information:**

- Before enrolling in any course, you should meet with the education service officer on your base/post first.
- The maximum tuition assistance per fiscal year (October to October) is \$4500 for all branches except for the Army (\$4000) and the Coast Guard (\$3750) and is dispersed at the rate of \$250 per credit hour.
- Tuition Assistance always pays first. If you are planning on also using VA CH 33 benefits with TA, we must certify the tuition balance by subtracting the TA payment.

#### **Tuition Assistance Unearned TA Funds Policy:**

NC Wesleyan's policy is to return any unearned TA funds on a proportional basis through the 60 percent portion of the period for which the funds were provided. TA funds are earned proportionally during an enrollment period, with unearned funds returned based upon when a student stops attending.

- 75% of TA received of TA received will be returned if the student withdraws after submitting the first assignment and through the end of the second week of classes.
- 50% of TA received will be returned if the student withdraws after the second week of classes, but before the end of the fourth week of classes.
- 25% of TA received will be returned if the student withdraws after the fourth week of classes, but before the end of the sixth week of classes. (60% of course is completed)
- No TA received will be returned if the student withdraws after the sixth week of classes.

**Christopher S. Cash Memorial Scholarship** - In 1993, Captain Cash graduated cum laude from North Carolina Wesleyan University with a bachelor's degree in physical education. As a dedicated student, he was chosen to

receive both the North Carolina Mary Morrow Scholarship, and the first annual Don Scalf Scholarship which was created to honor Weslevan's retired athletics director and coach.

After earning his undergraduate degree in 1993, he was commissioned as a Second Lieutenant in the North Carolina

Battalion, 120th Infantry Regiment, 30th Enhanced

community of Eastern North Carolina. Then in October

2003, he was mobilized in support of Operation Iraqi

National Guard. Captain Cash was an active-duty Soldier from 1986-1990, when he joined the North Carolina National Guard. While representing the 30th Infantry Brigade in 1991, Captain Cash was nominated for Outstanding Guardsman of the Year. In September of 1999, after Hurricane Floyd, he served as an essential

Separate Infantry Brigade headquartered in Jacksonville, North Carolina.

As a Company Commander, he led three platoons, and his soldiers provided support and protection to Iraqi citizens. During a pre-dawn patrol of a main supply route, in Bagubah, Irag on 24 June 2004, Iragi insurgents ambushed Captain Cash's 3rd platoon. After a fierce fight, 3rd platoon was ordered back to their Forward Operating Base Warhorse. Captain Cash then personally led his 1st platoon on a mission to secure two critical bridges in the center of the city. Focused on the safety of his men before his own, he ordered them to take cover. Captain Cash was mortally wounded by a machine gunner on top of a nearby building.

The Christopher S. Cash Memorial Scholarship will be distributed each year according to the College's Financial Aid criteria. Preference for receiving the scholarship will be given to a student or students who exemplify the qualities and traits of Christopher Cash, as demonstrated by volunteer service, plans for military service and leadership initiatives in school or youth organizations. Preference will also be given to students intending to serve in health and human services fields including exercise physiology. (Funds donated for the Christopher S. Cash Memorial Scholarship Fund by the Pitt Memorial Hospital Lights of Love Tree will support a student in the health care field.) Contact FinancialAid@ncwc.edu for more information.

#### **Military Officers of America (MOAA)**

The MOAA Scholarship Fund provides interest free loans, scholarships and grants to students seeking their first undergraduate degree.

Applicants for the programs must be planning to attend

an accredited college or university during the current school year as full-time students. All loans, scholarships, and grants are for students seeking their first undergraduate degree and are awarded for no more than five school years. No loans, scholarships, or grants are available for graduate-level studies. For further information, https://www.moaa.org/loans/

Applicants must be under 24 years old. Applicants must have a parent eligible for MOAA membership or be children of Active Duty, Reserve, National Guard, or retired enlisted military personnel. If the applicant served in a uniformed service before completing college, his or her maximum age for eligibility will be increased by the number of years he or she so served, up to five years. Applicants must have a high school GPA of 3.0 or higher. Children attending U.S. military academies and academy prep schools are not eligible. If selected for any Educational Assistance program, the sponsoring parent must have a paid MOAA (officers) or Voices (enlisted) membership throughout the college years and, if applicable, until the loan is repaid. Male applicants must affirm they have registered or will register for the Selective Service (by accepting the terms at the end of the application).

American Patriot Scholarship: Limited to students who qualify for the interest-free loan program and whose military parent has died on active service or is receiving Traumatic Servicemembers' Group Life Insurance (T-SGLI) payments. Currently, students receive scholarships of \$5,000 each school year.

**Designated Scholar Program:** MOAA considers all loan recipients for this program. Students chosen receive a \$5,000 interest-free loan and a \$500 grant named by the donor. Students must correspond with the donor or their designee each fall.

**Senior Grants:** MOAA will notify current loan recipients entering their final year in college of these grants in January of their junior year. Students who believe they are eligible for these grants and who do not receive an emailed link to the

application should email edassist@moaa.org for additional information. Recipients of Senior Grants become ineligible for further Educational Assistance programs. The number of grants awarded varies from year to year.

**General John Paul Ratay Educational Fund** 

**Grants:** These grants are limited to children whose military parent retired and subsequently died. Students qualifying for a loan who meet the criteria of a Ratay grant are automatically considered. Students who believe they are eligible for these grants and who do not receive a request for supporting documentation should email edassist@moaa.org. Funding for this grant is limited, so they may not be awarded annually.

# National Military Family Association - Military Spouse Scholarships

NMFA awards an average of \$500 for career funding and \$1,000 for degrees. Up to \$2500 is available for clinical supervision towards licensure in the mental health profession. Spouses

are also eligible for funding, typically \$1,000, to build their own businesses. This includes entrepreneurs, LLCs, direct sales, franchises, contractors, and other for-profit ventures. Any spouse with a valid military ID is eligible. #### **NC Scholarship for Children of Wartime Veterans**

North Carolina's Scholarship Program was created to show its appreciation for the services and sacrifices of its war veterans. The scholarship program applies to North Carolina schools. The scholarship is for eight academic semesters and the recipient has eight years to utilize the eight academic semesters. The Scholarship program has been established for the qualifying natural or an adopted child (if adopted before the age of 15) children of certain class categories of deceased, disabled, combat, or POW/MIA veterans. Applicant must be under the age of 25 at the time of application. The veteran's qualifying criteria must have occurred during a period of war. At time of application, applicant must be domiciled and a resident of North Carolina. The deadline to apply is February 14. All paper applications are now obsolete and will be returned to sender. In addition: Veteran parent was a legal resident of North Carolina at time of said veteran's entrance into that period of service in the Armed Forces during which eligibility is established, **OR** the applicant is the natural child or adopted child (if adopted before the age of 15) of an eligible veteran and the child/adopted child was born in North Carolina and has been a resident of North Carolina continuously since birth. <a href="https://www.milvets.nc.gov/services/scholarships">https://www.milvets.nc.gov/services/scholarships</a>

#### **National Society Daughters of the American**

**Revolution** The NSDAR awards multiple scholarships to students showing dedication to the pursuit of degrees in diverse disciplines including history, law, nursing, and education.

The DAR Scholarship Committee awards scholarships to qualified applicants regardless of race,



religion or sex. All applicants must be United States citizens. All multi-year scholarships, typically renewable up to four years, must be for consecutive years of attendance at an accredited college or university in the United States. - Scholarships of up to \$5,000 will be awarded to qualified applicants.
- Awarded scholarships are limited to one per family per semester.
- Applications for the fall semester will be accepted January 1 through April 30.
- Applications for the spring semester will be accepted August 1 through November 15.
- Fall semester scholarships will be awarded in August;
   Spring semester in January.
- Scholarships must be used by the end of the school semester for which the veteran is applying, or they will become null and void.
- Scholarships are restricted for tuition and fees only and will be paid directly to accredited schools.

#### Eligible Applicants Must:

- Be a citizen of the United States.
- Be retired, honorably discharged, active duty, or a member of the National Guard or Reserve.
- Completed Basic Training and follow-on training
- Separated with/current military rank of E-5 or below.
- Demonstrate a need for financial assistance.
- Participate in, be accepted to or currently enrolled in a VA-approved program or school at an accredited post-secondary institution.

<u>Women's Overseas Service League</u> Scholarship awards are based upon the decisions of the Scholarship Committee of the Women's

Overseas Service League Board of Directors. Scholarships average \$500.00 to \$1000.00 annually and may be renewed for a second year if the recipient maintains and reports satisfactory progress as delineated in the scholarship award

delineated in the scholarship award criteria. Scholarship granted to women who:

- Are committed to advancement in military or other public service careers.
- Demonstrated commitment through life experiences.
- Have successfully completed at least 12 semester (or 18 quarter) hours of study in any institution of higher education with a minimum 2.5 GPA.
- Are admitted for study in an institution of higher learning in a program leading to an academic degree (Associate Degree or higher). The program may be professional or technical in nature.
- Agree to enroll for a minimum of six semester (or nine guarter) hours of study each academic period.
- Agree to maintain academic standards.

Applicants must complete the Scholarship Application form in its entirety and include all documentation, including resume, transcripts, essays and references as specified on the application form. Applications must be postmarked no later than March 1 for consideration for the next academic year. <a href="http://wosl.org/scholarships/">http://wosl.org/scholarships/</a>

**AMVETS** Two scholarships are specific to Veterans, Active Duty, Guard/Reserves:

- The AMVETS Scholarship: \$4,000 (\$1,000 awarded annually over four years). (3) per year.
- The Dr. Aurelio M. Caccomo\* Family
   Foundation Memorial Scholarship: \$12,000 (\$3,000 awarded annually over 4 years), 2 awarded each year

Two scholarships are specific to children/grandchildren of Veterans, Active Duty, Guard/Reserves who are currently High School seniors:

- The AMVETS Scholarship: \$4,000 (\$1,000 awarded annually over 4 years) 6 awarded each year
- The JROTC Scholarship: \$1,000 (one payment of \$1,000), one (1) awarded each year -JROTC only.
   Proof from JROTC instructor must be included with application.

Military Order of the Purple Heart
Scholarship Program is a competitive scholarship
program that awards scholarships to Purple Heart
recipients and their spouses, children, and grandchildren
each year. To be eligible to apply for a Purple Heart
Scholarship, each applicant needs to be a member of
one of the following categories:

- A Purple Heart recipient who is also a member of MOPH, or
- 2. Spouse of a Purple Heart recipient who is a Member of MOPH, or
- 3. The direct lineal descendant (child, stepchild, adopted child, grandchild or step grandchild) of a Purple Heart recipient/Member of MOPH, or
- 4. Spouse, widow/widower, or direct lineal descendant as defined above of a service member killed-inaction or who died of wounds. If the Purple Heart recipient is listed as killed-in-action or died of wounds, supporting documentation must accompany the application.

In order to receive a Purple Heart Scholarship, applicants must meet the following three requirements:

- Be a graduate or upcoming graduate (current senior) of a high school or GED program, and
- Accepted by or enrolled as a FULL-TIME undergraduate student at an accredited U.S. college, university, or trade school at the time the scholarship is awarded, and
- 3. Maintain a 2.75 cumulative Grade Point Average based on an un-weighted 4.0 grading system.
  Graduate students are not eligible to apply.

Veterans United Foundation -The Veterans United Foundation Scholarship creates opportunities for family members of service members and Veterans to achieve their educational dreams. The scholarship program, launched in 2012, is funded by contributions from Veterans United Home Loans and its employees. The Veterans United Foundation Scholarship will be awarding up to 10 one-time scholarships for up to \$50,000 for this upcoming semester.

#### **Military Spouse Career Advancement Accounts**

**Program (MyCAA)** A component of the Department of Defense's (DoD) Spouse Education and Career Opportunities (SECO) program, MyCAA is a career development and employment assistance program. MyCAA helps military spouses pursue licenses, certificates, certifications or Associate's Degrees (excluding Associate's Degrees in General Studies, Liberal Arts, and Interdisciplinary Studies that do not have a concentration) necessary for gainful employment in high demand, high growth Portable Career Fields and Occupations. To be eligible, you must be a spouse of a service member on active duty in pay grades E-1 to E-5. W-1 to W-2, and O-1 to O-2 who can start and complete their coursework while their military sponsor is on Title 10 military orders, including spouses married to members of the National Guard and Reserve Components in these same pay grades.
